## Paws at the Park Day Camp Policies (Please Read and Initial)

\_\_\_\_\_ 1. **Day Camp:** All dogs must complete a temperament evaluation. Paws at the Park reserves the right to refuse or to reject any dog that might be a safety hazard to its self or other dogs in our care or staff member. This includes, but is not limited to dogs who are aggressive, anti-social, toy or people possessive, anxious, or physically ill. All dogs must be at least 6 months or older to attend day camp/boarding and all dogs must be spayed or neutered. These 2 items may be waived on a case-by-case basis.

\_\_\_\_\_ 2. **Vaccinations:** All dogs must have current vaccinations against DHPP (or proof of protective antibody titer), Bordetella, Rabies and have proof of negative fecal (stool) exam. Please note: getting a Bordetella vaccination is not a guarantee your dog won't get Bordetella. Your dog will not be admitted into Paws at the Park until we have proof of vaccinations. Three notices will be given prior to shots being due. The third reminder (due date) will also be notice that you can no longer bring your dog in without proof of updated vaccinations. Also NOTE: If you have not been here for several weeks or months and your dog is past due for any vaccination, you will not be able to drop him off without proof of vaccination.

\_\_\_\_\_ 3. **Flea Protection:** All dogs are required to have flea protection. Your dog must be on a veterinarian-approved form of flea control. Acceptable flea treatments are (but not limited to) K9 Advantix, Seresto collar and Revolution. Any dog that has fleas will not be allowed in our facility.

\_\_\_\_\_ 4. **Collars and Leashes:** All dogs must be on leash when entering and exiting Paws at the Park. All dogs must also have a QUICK RELEASE collar. NO BUCKLE COLLARS. THIS IS FOR SAFETY REASONS!!!

\_\_\_\_\_ 5. **Toys and Beds:** You may not bring your own toys or beds from home. This could cause possessive behavior.

\_\_\_\_\_ 6. **Food:** If you want your dog to be fed in day camp, please bring your own food from home

\_\_\_\_\_ 7. **Service Fees:** All fees for services are due at morning drop off. Acceptable forms of payment are checks, credit cards & cash.

\_\_\_\_\_ 8. **Late Fees:** If you do not arrive for pick up by closing, your dog will have to stay overnight and you will be charged overnight and any other appropriate fees.

### HOLD HARMLESS / RELEASE AGREEMENT

Paws at the Park, its owner, employee(s), representative(s) or any other person(s) affiliated with the company shall hereinafter be referred to as "Paws at the Park."

By signing this form, you or your representative(s) \_\_\_\_\_ (print dog owner's name) shall hereinafter be referred to as "Owner," and agree not to hold "Paws at the Park" liable or sue for any injuries and/or death to your dog(s) \_\_\_\_\_ (print dog's name) while in the care of "Paws at the Park."

Although, Paws at the Park screens the dogs for temperament, watches the dogs carefully, and **do not** take aggressive dogs, day camp can be hazardous. They can get rambunctious at times and we cannot be held responsible for injuries and/or death that may occur in and out of the day camp.

• If, in my absence, my pet should become ill, injured or in need of veterinary care, Paws at the Park has my permission to consult with my veterinarian. If my pet should require immediate care, I hereby give Paws at the Park permission to bring my pet to Park Street Veterinary Clinic. I understand that I am responsible for all veterinary costs.

• I understand that my dog will be allowed outside on a daily basis at Paws at the Park.

• I hereby declare that my dog has never shown aggression, bitten, injured or killed another dog or person. If my dog does I agree to pay all bills associated with the incident.

• I hereby declare that my animal has not been exposed to any communicable diseases within the last 30 days, and is fully vaccinated in accordance with Paws at the Park policy.

• I understand that any photos taken of my pet while attending day camp are the property of Paws at the Park and may be used for advertising on social media or in print at their sole discretion.
